 - o to advise the School Board on any matter the latter is required to submit to it;
 - to advise the School Board on any matter conducive to the most efficient operation possible and;
 - o to inform the School Board as to the needs identified by the parent representatives.

- SEAC meets once per month. Subcomittee participation is optional.
- Parent members of SEAC are designated by Parents Committee at their first meeting of the school year.

- The names of all interested parents will be shared with the Parents Committee
