Arrival to Class and Class Dismissal  Bullying (physical, emotional, cyber)  Classroom Behaviour	<ul> <li>Expectations</li> <li>Students will attend school all possible days.</li> <li>Students will check in at front reception with parent verification if they are late.</li> <li>Parents will ensure that students attend school; in the event a child is absent for a legitimate reason (ie. appointment, illness) the parents will notify the school by phone or email.</li> <li>School staff will take attendance and communicate with parents in the event that there are any concerns.</li> <li>Students will be in class and prepared to work (ie. sitting at their assigned location, with their required materials) before the bell rings to begin class.</li> <li>School staff will keep records of class lates.</li> <li>The teacher dismisses students at the bell. The bell is a reminder.</li> <li>There will be Bell to Bell learning</li> <li>Students will behave appropriately, respecting individual differences and diversity. They will report and inform (parents/guardians, school staff, friends) if they are being bullied or if they see someone else being bullied. Students will help someone who is being bullied by taking a stand – reporting and supporting.</li> <li>Parents will watch for signs that their child may be the victim of bullying and watch for signs that their child is exhibiting bullying behavior. They will speak to a teacher or administrator if their child is being bullied or they suspect that their child is bullying others. They will encourage open conversations with adults and encourage their children to tell a responsible adult if they are being bullied or suspect others are bullying.</li> <li>School staff will act as appropriate role models for all staff and students. They will take every precaution to ensure that students are supervised at all times. They will reinforce the message that bullying is not accepted or tolerated. They will be observant of signs of distress or suspected incidents of bullying. The staff will treat all reports or observed incidences of bullying</li></ul>	<ul> <li>Pyramid of Interventions for Infractions</li> <li>Parents will be notified by school staff in the event that a child is absent and not verified.</li> <li>After 10 unjustified absences, an administrator will send a letter of concern home and put in student file.</li> <li>If a student is absent 10 consecutive days in a row a letter of concern is sent to the parent and Youth Protection. A letter may be sent if the school is concerned about any number of absences.</li> <li>A student who continues to be absent and is not justified will have a plan-of-action meeting with school team, parent/guardian and student.</li> <li>A student truant from class will receive an In School Suspension.</li> <li>A student truant from class will receive an In School Suspension.</li> <li>A student truant from class will receive an In School suspension.</li> <li>A student who is late (non-verified) for class will be assigned an ISS</li> <li>If the student continues to be late, they may be sent home and will be required to return with his/her parent(s) to develop a plan.</li> <li>Official warning to stop offending (verbal and written) to the students and parents.</li> <li>A student may be automatically suspended from school if the act of bullying is considered severe regardless if there have been previous issues.</li> <li>In the case of a serious incident of bullying, parents of both the victim and the student(s) committing the bullying-type behaviour are notified. The parents are informed of the allegations and are also informed about the student's responses to these allegations (verbal and written).</li> <li>If they do not stop engaging in bullying behaviours after any warning from school staff, students will be suspended from school.</li> <li>Students who bully others may face one or more of the following consequences:         <ul> <li>Involvement in mediation;</li> <li>Parents will be contacted by the school;</li> <li>Recommendatio</li></ul></li></ul>

Students will complete assignments to the best of their ability	<ul> <li>The student will receive a minimum of one (1) lunch detention unless the teacher indicates differently.</li> <li>If a student is sent out of class more than once in one day, they will receive a school suspension for the rest of the day or the following day.</li> <li>The parents may be contacted by the teacher.</li> <li>If a student persists in misbehaving, a team conference will be held with the student, his/her parents, the behaviour technician, and an administrator.</li> <li>A student who continues to misbehave has placed him/herself at high risk: at this point, the student will be served with an out of school suspension and a meeting will be scheduled with a director.</li> <li>A student who does not hand in an assignment on time may be</li> </ul>
Assignments	<ul> <li>and hand them in as requested by their teachers.</li> <li>Teachers will provide students with sufficient time to complete assignments. Teachers will monitor and keep a record of assignment completion.</li> </ul>	<ul> <li>assigned WIN (Work In Now) during lunch in the reflection room.</li> <li>Failure to attend WIN will result in a lunch detention or suspension.</li> <li>A student who continues to not hand in assignments as requested may be assigned an academic suspension.</li> </ul>
Drug or Alcohol Use and the Sale of Drugs or	<ul> <li>Students are expected to dress in a professional manner for a place of education. Hadley-Philemon gear is welcome and encouraged.</li> <li>Wear clothing with positive and non-violent images/phrases.</li> <li>Wear clothing with no references to drugs or alcohol.</li> <li>Wear pants, shorts, and skirts that cover undergarments and buttocks.</li> <li>Wear clothing that covers the chest and midriff.</li> <li>Hats and hoods are to be removed for safety concerns and to show respect.</li> <li>Hats and coats are welcome outside but must be put in your locker once you enter the building (along with your school bags).</li> <li>Students will refrain from using and/or trafficking drugs or alcohol at school.</li> </ul>	<ul> <li>If a student does not respect the following guidelines, they will be referred to an administrator.</li> <li>An administrator will talk to the student one-on-one, and if the student's attire violates the dress code, they will be asked to change. If it is a repeated offence concerning a hat, the hat will be kept in the office for the remainder of the day.</li> <li>If the student refuses they will go home or sit in the reflection room for the remainder of the day.</li> <li>The administrator will follow up with the teacher and may contact the parent</li> <li>A student who is caught either under the influence, in possession, or trafficking drugs or alcohol will be suspended for 10 school days (8 days OSS and 2 days ISS).</li> </ul>
Alcohol	<ul> <li>Students will not present themselves at school or at school events under the influence of any drug or alcohol.</li> <li>The school Administration reserves the right to perform any search deemed reasonable to ensure the safety of students and staff.</li> <li>Please refer to school board policy</li> </ul>	<ul> <li>OSS and 2 days iss).</li> <li>The police will be involved if the students are in possession of drugs.</li> <li>Parents will be notified. A re-entry meeting with parents, administration and a Director will be held after the suspension.</li> <li>The school Drug and Alcohol Counsellor will follow up with the student upon his/her return to school.</li> <li>A student who is caught trafficking drugs or with a quantity of drugs deemed to be for the purpose of sale, will be suspended for 10 school</li> </ul>

Electronic Devices Failure to Serve a Detention	<ul> <li>Students will be allowed to use portable electronic devices (i.e. iPods, PSPs) and cell-phones (check texts messages/time ONLY) during NON-CLASS TIME ONLY in the halls, cafeteria or outside the school.</li> <li>Electronic devices ARE NOT to be used in the classrooms for personal use (text, call, listen to music and check-time).</li> <li>Earbuds are to be removed from the students' ears.</li> <li>In the event that a student is served a detention, he/she will serve it as requested.</li> <li>The person assigning the detention will notify the student that they have a detention.</li> </ul>	days pending a meeting with a director at the school board which may result in a discipline committee hearing.  A student who is caught a second time either under the influence or in possession of illegal drugs or alcohol will attend a meeting with a director at the school board which will result in a discipline committee hearing and potential expulsion from school.  Refusal of a search is an automatic 10 day suspension pending a meeting with a director at the school board.  Students WILL NOT be reminded to use such devices appropriately in assigned areas and any devices used in or interrupting classes the student will be:  Asked to bring their phone to the office.  The student will get their phone back at the end of the day and will be assigned a detention  Out school suspensions will be assigned if a student refuses to hand over device.  Repetitive use in restricted areas may result in suspension and or loss of privileges and/or suspension  If a student is late to a detention they will serve the rest of the detention and one the next day  Failure to report to a detention will result in two detentions  If the student fails to report to these detentions they will receive an in
Leaving School Property	<ul> <li>Hadley students are not permitted to leave school property.</li> <li>Philemon Wright Students can leave school property at Lunch</li> </ul>	school suspension     Hadley student may be suspended up to 3 days for leaving school property
Physical Aggression or Physical Assault	Students will refrain from any type of physical confrontation (play fighting or fighting).	Students who enter into a minor physical altercation or play fighting (ie. pushing/shoving each other) may be suspended up to 3 days. Parents will be notified.  Students who are involved in a physical confrontation whereby punches or kicks are administered will be suspended for up to 5 school days. The Behaviour Technician and/or police may be involved and will intervene with the student.  Parents will be notified. As well, a re-entry meeting with parents will be required.
Smoking/ e- cigarettes/ Vapes	<ul> <li>Philemon Wright students will refrain from smoking on school property.</li> <li>Hadley Students are not permitted to smoke.</li> </ul>	A Hadley student who is caught smoking, or in possession of cigarettes or a lighter will be suspended for 3 school days. Parents will be notified.  Vapes or cigarettes will be confiscated if found on school property A student smoking on school property will be suspended up to 3 days.  The student may receive a By-law fine.
Theft	Students will respect the belongings of others. Under no circumstance is it acceptable to take something that does not belong to oneself.	A student may receive a by-raw line.  A student who steals will be required to repay the amount or dollar value of what was stolen.  The police may be involved and will intervene with the student; the parents will be informed. In cases that warrant it, charges will be laid.  A student who steals at school or during the school day will be suspended externally for up to three school days.
Possession of Weapon	<ul> <li>Students will not have any type of weapons in their possession at school.</li> <li>The school Administration reserves the right to perform any search deemed reasonable to ensure the safety of students and staff.</li> <li>Please refer to school board policy</li> </ul>	<ul> <li>A student in possession of a weapon at school will be suspended up to 10 school days. The police will be involved and will intervene with the student. Parents will be notified; a re-entry meeting with parents will be held.</li> <li>In the event a student is caught a second time in possession of a weapon at school, he/she will be referred to a meeting with a director form the school board which may result in a discipline committee hearing.</li> </ul>
Vandalism	<ul> <li>Students will be respectful of all school property.</li> <li>School staff will monitor and report any incidents of vandalism.</li> </ul>	A student who vandalizes school property will be required to compensate for full repair of the vandalism. Depending on the circumstances, the student may be assigned community service.      A student who vandalizes at school or during the school day may be suspended externally.      The parents will be advised.      The police may be advised and charges laid if appropriate.
